Explanation: We had originally had our voluntary audit with an external CPA firm scheduled for 3/9/20, with intent to file before the May 15, 2020 deadline. However, the week prior, Executive Director Anne Martin became ill with COVID-19 symptoms that lasted 6 weeks, necessitating postponing the audit, and filing an extension of time to file the 990, so that we could reschedule the audit and file the 2019 990 by the November 16, 2020 deadline. Anne Martin mailed Form 8868 "Application for Automatic Extension of Time to File an Exempt Organization Return" on 4/22/2020, via First-Class USPS mail using a Pitney Bowes mail machine to print the postage. The paper form was mailed to Department of the Treasury, Internal Revenue Service Center, Ogden, UT 84201-0045. We have a photocopy of the mailing label showing the date mailed. We were able to reschedule the audit in late August 2020, and received the audit report 11/5/2020. However, 10/26/20, we received notice CP259A from the IRS stating "You didn't file a required annual tax return," in reference to the 2019 990. This was when we learned that our Form 8868 requesting an extension must not have been received. Upon receiving the audit report 11/5/20, we promptly completed the 990 by the 11/16/20 deadline, as planned. Due to staff illness with COVID-19 symptoms in March through April 2020, and subsequent USPS difficulties, as well as our belief that we were, in fact, filing on time with our requested extension that we had mailed on time, we hope you will consider this reasonable cause and waive any penalties.
